Eligibility: Open to 4-H/FFA horse members 14-18 years of age as of January 1, 2024, who have completed at least one year of 4-H or FFA. Previous Horse Royalty winners are ineligible to participate.

Entry Deadline: Contestant entries, with a picture of yourself, must be received at the Franklin County Extension Office by April 1, 2024, and include a \$30.00 application fee payable to Franklin County 4-H Horse Advisory. Entry forms are available on the Franklin County 4-H Horse Program website at: F.C. 4-H Horse Advisory Committee - Horse Royalty (google.com). (https://sites.google.com/view/fchorse/franklin-county-fair/horse-royalty)

Contest Components: The Horse Royalty Program is based on completion of the following components:

- 1. The first meeting scheduled for Wednesday April 11, 2024, at 7:00 PM (location to be determined) is mandatory attendance. Exception: If you are unable to attend, you must notify Veronica Boysel, Royalty Advisor, that you have made arrangements to have a parent, guardian, or a 4-H club Advisor attend on your behalf. Notification can be sent to Veronica Boysel at 614-216-1773. No penalty will be assessed if notice is received at least one week prior to the mandatory meeting. If you miss the mandatory meeting and did not notify a Royalty Advisor, you will be disqualified and forfeit your \$30.00 application fee. If you are late to the meeting a 5-point deduction will be given. If you are more than 15 minutes late a 10-point deduction will be given or you may be disqualified from Royalty Competition and forfeit your \$30.00
- 2. Participation in one Royalty Showmanship class at a Franklin County 4-H Horse Advisory show on May 5 or June 8. If you participate in both Horse Advisory shows, the best score will be used. You will be judged against standards, NOT against each other.
- 3. Participation in one Royalty Horsemanship <u>or</u> Equation class at a Franklin County 4-H Horse Advisory Show on **May 5 or June 8**. Chaps are permitted but not required. If you participate in both Horse Advisory shows, the best score will be used. You will be judged against standards, NOT against each other.
- 4. Volunteering for a Franklin County 4-H Horse Advisory Committee show is required. All candidates must volunteer by setting and removing both the jumps and the trail course on **either May 5 or June 8**. You must be present for all the set up and removals to earn full points. In addition, we will discuss another volunteer opportunity at the mandatory meeting that will involve giving back to the fairgrounds.
- 5. Royalty Essay must be emailed to kathymyers@columbus.rr.com by **noon**, **July 1**, **2024**, and your essay must be displayed in a Frame by **8:00 AM** on **July 15**, **2024**, on your Stall door.
  - a. Essay Topic: "Using your personal experience, what suggestions would you make to increase youth involvement in 4-H?"
    - i. Essays are due to kathymyers@columbus.rr.com in PDF form by **noon**, **July 1**, **2024**. Failure to meet the deadline will result in a score of 0.
    - ii. Essays should be typed, single spaced and one full page in length, with Times New Roman 14pt font.
    - iii. Each essay should have a title and list your name. Essay must follow the rubric attached in support of this topic question.
    - iv. You are responsible for printing a copy of your essay and displaying it on a Horse Royalty board on your stall at fair by 8:00 AM first day of fair.
- 6. All candidates must declare their riding seat on the Royalty entry application, (this is the seat you will compete in for the riding points). Once the application is submitted there can be no change of seat. If the horse is unable to compete at the time of the qualifying shows or a make-up show as determined by Royalty Advisors, you will forfeit your points for this event. You may not substitute or borrow another horse.
- 7. Participation in one Royalty Ride-in at a Franklin County 4-H Horse Advisory show is required. If you attend both shows, you are expected to participate in both ride-ins, otherwise a 10-point deduction will be given. Candidates are to dress in appropriate show attire for their respective declared seat with club sash.

Candidates will be introduced per submitted bio and are required to either lead or ride their horse project into the ring. A candidate will receive a 5-point deduction for not having proper riding attire of their respective declared seat, tack or sash. If you are late to the ride-in a 5-point deduction will be given. In addition, candidates are expected to participate in the Franklin County Fair Ride-in on their horse.

- 8. Royalty Luncheon: June 26, 2024, 11:00 a.m. is mandatory and must be attended from start of luncheon to finish at 4635 Trueman Blvd. Hilliard Ohio 43026. If you are late to the luncheon a 5-point deduction will be given. If you are more than 15 minutes late a 10-point deduction will be given or you may be disqualified from Royalty Competition and forfeit your \$30.00
  - a. An Autobiography must be submitted at the Horse Royalty Luncheon.
  - b. 10-minute Interview will also take place for each candidate with two judges.
  - c. Written Test over project books: *Beginning Horse Management* (174), *Gymkhana* (186), and *Uniform Rules for 4-H Horse Shows* (179R).
- 9. Horse Requirements: All royalty candidates must have a horse project on special exhibit at the Franklin County Junior Fair and participate in Horse grading. Exception is only if your horse has died. It is expected that a lame horse can still be on special exhibit. All royalty candidates will be stalled with their 4-H club or FFA chapter and must have their royalty frame and essay on stall exhibit.
- 10. Ties: Ties are allowed for showmanship, horsemanship, equitation, autobiography, interview, test in first, second and third runner up placings. In the event there is a tie for the winner, the following tie breakers will be used, in the following order:
  - a. The highest test score will be the winner. If there is still a tie for the winner then,
  - b. The interview scores will be used. If the interview score still does not break the tie then,
  - c. The Autobiography score will be used. If there is still a tie,
  - d. The Showmanship score will be used.
- 11. Coronation: Monday, July 15, 2024. Dress is semi-formal for all contestants.
  - a. Awards for the Horse Royalty Contest are acquired by the Advisors and are paid for by sponsorships obtained by the candidates and/or the 4-H Horse Advisory Committee.
- 12. Horse Royalty Scoring (must complete at least 6 to participate in the crowning ceremony)

a. Showmanship 100 points possible (PAS Scale) \* b. Horsemanship/Equitation 100 points possible (PAS Scale) \* c. 4-H Horse Advisory Show Volunteering 50 points possible d. Written Test 150 points possible e. Autobiography 100 points possible f. Interview 100 points possible g. Royalty Essay 50 points possible h. Securing Sponsorship 25 points possible

- Complete at least 6 of the scoring categories. In order to participate in the crowning ceremony, all candidates must complete at least 6 of the 8 categories for points.

- 1. **Eligibility:** Open to 4-H horse members 18 years of age as of January 1, 2024, who have completed the grading process for their horse project or horse relationship project.
- 2. Members who have never brought a horse to fair must have completed at least 3 years of a horse relationship project (Horseless Horse-#173 is not a relationship project).
- 3. **Entry Deadline:** Golden Boot award forms can be found <a href="https://sites.google.com/view/fchorse/forms">https://sites.google.com/view/fchorse/forms</a> and are due by **June 15, 2024** to Kathy Myers at <a href="https://sites.google.com/view/fchorse/forms">kathywers@columbus.rr.com</a> or Kathy Kerr at <a href="https://kathykerr2@gmail.com">kathykerr2@gmail.com</a>.
- 4. **ALL Golden Boot** recipients must attend the mandatory meeting that takes place the first day of fair. Failure to attend is forfeit of award.

**Please note** - Members with horses On Special Exhibit will receive a horse sash. Horse relationship members will receive a rosette ribbon. All recipients will be awarded a t-shirt and are encouraged to wear the t-shirt during the horse show on the last day of the fair.

The Franklin County Equestrian Drill Team is a choreographed equestrian performance set to music. A committee of advisors will choose up to 16 participants and 2 alternates as well as 2 captains from the entry forms received. The decision of the committee will be final and cannot be contested or disputed. All participants will receive a t-shirt provided by the Franklin County 4-H Horse Advisory Committee. The Drill Team Advisors will determine the choreography of the routines. All participants as well as parents/guardians must comply or will be asked to resign their position on the team.

- 1. **Eligibility:** Open to 4-H horse members 12-18 years of age as of January 1, 2024, and on special exhibit. Walk/Trot and Novice riders are not eligible.
- 2. **Entry Deadlines**: Entries must be mailed to Lisa Wiley, 2436 Stewart Hollow Court, Hilliard, Ohio 43026. Entries must be received by **June 7**, 2024. Entry forms can be found at Franklin County 4-H Horse Program website at: https://sites.google.com/view/fchorse/forms.
- 3. **Requirements:** There will be four (4) mandatory practices. All practices will be held at the Franklin County Fairgrounds at 7:00 pm (dates TBD). Transportation to and from practices will be the rider's responsibility. A release of liability must be signed prior to the first practice. Approved equine protective headgear will be required at all practices. The drill team requires team effort, which requires attendance at all practices. Absence of a participant affects the outcome of the overall performance; therefore, an absent participant will be replaced with an alternate.
- 4. **Required Attire:** Participants will wear formal show attire for the Sunday performance and their Drill Team t-shirt for the Wednesday and Saturday evening performances. Saddle and bridle must be from the same seat.

### GENERAL HORSE EXHIBITOR RULES

Notice: Failure to comply with the following rules will result in forfeiture of fair awards and possible expulsion from the Franklin County Fairgrounds.

- 1. **Safety/Waivers**-All exhibitors of 4-H Horse Projects (On special exhibit or not on special exhibit) must have successfully completed EquiStep, the Ohio 4-H Equine Safety, Training & Educational Program. The following must be on file with the Franklin County Extension Office:
  - The Ohio 4-H Equine Activities Release of Claims Waiver, signed by 4-Her and guardian (signed and submitted for current year) and
  - the Franklin County Agricultural Society Equine Activities Release of Claims Waiver, signed by 4-Her and guardian (signed and submitted for current year.)
- 2. **Exhibitor Rules and Guidelines:** All horse exhibitors are required to abide by the Junior Fair General and Animal Exhibitor Rules listed in the General Junior Fair Exhibitors' Rules and Guidelines as well as the rules listed below. Please read all rules and guidelines carefully. Exhibitors who disregard rules, are disruptive or create a safety concern may be asked to leave the fairgrounds at any time. Any questions about any rule or guideline should be first directed to your 4-H Club Advisor. If questions still exist, please contact Gary Russell, 4-H Horse Advisory Committee Chair at 614-563-5901 for further clarification.
- 3. Horse Project Evaluations: All horse projects must be evaluated at the designated evaluation time in order to participate in any Junior Fair Horse Event. Horse exhibitors will have project book(s) and record book(s) reviewed/graded by their club advisor at a time arranged with club members. The feed tag exercise, all project knowledge, and skills will be evaluated at the fair on Monday, July 15. Grading will begin at 8:30 am. See the exact schedule on page 1. Any 4-H project book that does not have "Planning Your Project" pages in the front of the book are required to print "Planning Your Project" pages from the go.osu.edu/fchorse website and turn them in with the project book for grading. Members who are taking more than one 4-H horse project book (174-189) but using the same project animal will only need to go through the horse inspection portion of evaluation once. The horse inspection portion includes backing and turning a horse, horse's health and appearance and appearance of exhibitor, tack and equipment. The horse inspection scores will be used for all the horse projects enrolled by the 4-H member using that project animal. If a member is showing/exhibiting more than one project animal, whether owned or leased, the member must take both project animals through the horse inspection portions of the evaluation. Horse projects will be cross checked and verified against the specific horses which were submitted and registered by the member during the April 1 enrollment process. Horse wash racks will be closed during grading.
- 4. **Horseless Horse Evaluations:** Horseless Horse Project members are to bring to evaluation their project book with the required number of activities completed; a story about their Horseless Horse project experience and an educational display on a topic covered in the 4-H Horseless Horse Project Book (173).
- 5. **Partnership Evaluations:** Partnership evaluations will take place at the fair on **Monday, July 15** in the Activities Tent. Experienced Horse Project members are to bring their completed summary sheet to evaluations. Novice members are not required to bring any written documentation to evaluations.
- 6. **Horse Relationship Project Evaluations:** Horse Relationship Project members should bring to evaluation their completed project books, completed log sheet, a minimum 1-page maximum 2-page summary of what they did and learned by doing Relationship and a horse-related educational display.
- 7. **Health Requirements:** All horses exhibiting at the fair are **required** to submit:
  - a. Documentation that the horse has received the following core horse vaccines **after March 1, 2024** (Eastern/Western Equine Encephalomyelitis, Rabies, Tetanus, West Nile Virus & Flu/Rhino).
  - b. Documentation of a **negative Coggins test after January 1** of the current year.
  - c. Documentation along with the <u>2024 Vaccine and Coggins Requirement Form</u> must be submitted with the Stall Request Form by **June 8**.
  - d. Horses exhibited must not be under quarantine and must show no symptoms or evidence of an infectious or contagious disease.
  - e. The fair veterinarian may inspect horses at any time.
- 8. No Use of Studs: Junior Fair Horse Exhibitors are not allowed to show/exhibit pony or horse studs.

- 9. **Project Animal Requirements:** Exhibitors must use their own project animal for evaluation. All family or shared-horse lease project members may use the same animal for evaluation purposes. 4-H members must designate their project animal(s) by **April 1** of the current year. Each exhibitor must have on file at the OSU Extension Franklin County office a completed Horse ID Form together with a minimum 3 X 4 inch color photo of each side of their project horse (**full body, no tack except halter/lead, no blankets**) before **April 1**. During the evaluation process, projects animals will be validated against the list of designated project animals submitted. If the horse project animal is leased, a completed and signed lease agreement must be on file with the OSU Extension Franklin County Office by **April 1**. There will be a **\$40** stall fee accessed for each horse on Special Exhibit. The **\$40** stall fee will be due with fair entries in June.
- 10. **Exhibitor Riding Requirements:** Only the exhibitor may ride or sit on the horse/pony at the Fair. The violator and the horse will be disqualified from further participation at the Fair. Junior Fair Horse events (except Model Horse Show) are only open to regular 4-H members (age 8 and in the 3<sup>rd</sup> grade or age 9 any grade as of January 1st of the current year up to age 18).
- 11. **Adult Supervision Required:** Exhibitors under the age of 16 must have a parent, guardian or designated adult supervisor on the grounds or they are not permitted to ride in shows, the practice arenas or anywhere on the grounds. Designated supervisors must be 18 years of age or older. Violators may be asked to leave the Fairgrounds.
- 12. **Rules Governing Junior Fair Horse Events:** These General Horse Exhibitor Rules will govern all classes and events. In addition, exhibitors are subject to the rules and regulations stipulated in both the Junior Fair and Senior Fair Books, and the *Uniform Rules for 4-H Horse Shows (4-H Pub. #179R)*. Exhibitors should purchase a copy of the *Uniform Rules for 4-H Horse Shows* from the OSU Extension, Franklin County office.
  - Franklin County 4-H Horse Advisory Committee's guidelines for pattern classes: No patterns for Walk-Trot. Novice exhibitors will do patterns, and if the class requires patterns, all participants will do the pattern followed by rail work with riders going at least one direction on the rail. Before the beginning of the show, the Judge may make the decision to only call back top pattern riders for rail work. (New 2024 179R rule: If the pattern includes a walk/show walk, jog/trot/show gait, lope/canter (both directions of the arena), and a back, rail work is optional.) Rail work requirements will be announced at the beginning of the show.
- 13. **Family Horse Project Requirements:** Exhibitors enrolled in Family Horse Project(s) may share the animal(s) to participate in evaluation, 4-H Advisory Committee Show, the Junior Fair Show, Junior Fair Musical Freestyle, Junior Fair Versatility and Junior Fair Fun Shows. The family horse category includes siblings, members of the same household and cousins. An exhibitor may exhibit two Family Horse Projects.
  - a. A family horse may not be entered more than once in any class in which all horses are required to enter the arena simultaneously, such as, Showmanship, Western Pleasure, Western Horsemanship, Ranch Pleasure or Equitation.
  - b. The family horse may run as many times as it has eligible family member exhibitors in any class where the horses work individually and never enter the arena as a group, such as, contesting, reining, western riding, over fences.
  - c. Only one family member may use the family horse project to participate in Junior Fair Horse Royalty or PAS.
- 14. **Shared-Horse Project Requirements:** The spirit of this rule is to help 4-H members without access to a horse, bring a horse to fair. Two exhibitors, each of whom have not enrolled any other horse, may jointly enroll one horse. (Enrolled means each 4-H member has submitted a horse ID form, picture of the horse and copy of a signed lease agreement prior to the **April 1** horse possession date of the current year.) The horse may be a leased horse with both exhibitors sharing the lease or the horse may be owned by one exhibitor with the other exhibitor leasing the horse from the owner. There may be no more than two riders for a Shared-Horse. Exhibitors enrolled in a Shared-Horse Project may share the animal to participate in evaluations, 4-H Advisory Committee Show, the Junior Fair Show, Junior Fair Musical Freestyle, Junior Fair Versatility and Junior Fair Fun Shows.
  - a. A Shared-Horse may not be entered more than once in any class in which all horses are required to enter the arena simultaneously, such as, Showmanship, Western Pleasure, Ranch Pleasure, Western Horsemanship or Equitation.

- b. The Shared-Horse may run twice in any class where the horses work individually and both exhibitors are in the same class such as, Contesting, Reining, Western Riding and Fence classes.
- c. A Shared-Horse may be used by only one exhibitor to participate in Junior Fair Horse Royalty.
- d. A Shared-Horse may not be registered as a PAS horse trying to qualify for the State Junior Fair Horse Show. (Registered meaning completing and submitting the Out of County PAS Registration form and Horse ID form with picture.) A 4-H member participating at the county fair with a Shared-Horse Project is not eligible to qualify in a PAS show for the State Fair Horse Show with another horse.
- e. An exhibitor with a Shared-Horse Project may only enter the Shared-Horse and is not eligible to enter two horses as described in rule 15.
- f. If 4-H members are permitted to bring two horses to fair, Shared-Horse Project members are still only permitted one horse at fair.
- 15. **Number of Horse Exhibits:** There is no limit to the number of horses that can be enrolled on April, 1. However, an exhibitor may only enter up to two horse project animals on Special Exhibit for fair with the exception as noted in rule 14 that exhibitors with a Shared-Horse Project may only enter the horse that is being shared. Because of limited barn and stall space, there may not be room for the second horse project to be exhibited. Exhibitors will be notified before the fair if a second project horse is not allowed. No one will be allowed to have more than two horses at the fair on Special Exhibit. There will be a \$40 stall fee accessed for each horse on Special Exhibit. The \$40 stall fee will be due with fair entries in June.
- 16. **Types of Riders:** All Junior Fair Horse Exhibitors must declare a riding level at the time of Junior Fair Entry **June 8**. Junior Fair Horse exhibitors will only be allowed to ride in horse show classes at their declared riding level throughout the entire week of the current Franklin County Junior Fair. No exhibitor will be allowed to move up or down in riding level at any time during the current Franklin County Junior Fair. Show officials will excuse any Junior Fair horse exhibitor who enters the show ring in the wrong riding level class. The 4-H Horse Advisory Committee reserves the right to lower any exhibitor to Walk-Trot if deemed necessary for safety.
  - A. **Walk-Trot** Exhibitors (the 4-H member, not horse/rider combination) who have shown in a lifetime total of four or fewer cantering classes in previous fairs, open shows, IEA or IEA type shows. Walk-trot riders have never participated in any PAS State Fair qualifying show. Exhibitors must be in their 1<sup>st</sup> or 2<sup>nd</sup> year of a horse project to declare walk-trot. Exhibitors who show in walk-trot classes are ineligible to show in any other riding classes at the current Franklin County Junior Fair. Walk-trot exhibitors are prohibited from loping/cantering their horse any time while on the fairgrounds. If a walk-trot class is combined with a novice class, then all appropriate riders may show in the combined class, which will be limited to walk-trot. Walk-Trot exhibitors will wear equine approved safety headgear (helmet) whenever they are riding or showing (including showmanship) their horse/pony.
  - B. **Novice** Exhibitors (the 4-H member, not horse/rider combination) who have shown in a lifetime total of four or fewer cantering classes in previous fairs, open shows, IEA or IEA type shows. Novice riders have never participated in any PAS State Fair qualifying show. Exhibitors must be in their 1<sup>st</sup> through 4<sup>th</sup> year of a horse project. Novice riders will not be permitted to participate in Equitation Over Fences, Working Hunter or any Gymkhana classes (timed events). Exception: Fun show classes designed for novice and walk-trot riders. Novice riders will not be permitted to enter Versatility program. Novice riders will be permitted to participate in Hunter Hack classes but with cross rails only. These exhibitors may be expected to show their horse in a canter or lope. Exhibitors who show as novice riders may only enter novice classes at the current Franklin County Fair. Exception: If novice classes are combined with walk-trot classes, then all appropriate riders may show in the combined classes, but only at walk-trot. Novice riders may wear Western style hats for Western Showmanship classes but will wear equine approved headgear at all other times while riding or showing their horse.
  - C. Age Categories Exhibitors who select to ride in classes for their appropriate age must ride in the same age category of classes throughout the current Franklin County Junior Fair. Riders may not enter more than one age category class and may not ride in age category classes and walk-trot or novice classes. Entries will be divided into three approximately equal size divisions (Junior, Intermediate and Senior) based on the age of exhibitors entered. Age

Category riders may wear Western style hats for Western Showmanship classes but will wear equine approved headgear at all other times while riding or showing their horse.

Mentally and/or physically disabled exhibitors are permitted to show in walk-trot or novice classes beyond the restrictions listed above contingent upon the approval of the horse show rules committee.

- 17. **Ponies:** A pony is 58" and under. If showing in a pony class, you may not enter a similar horse class for your age group or riding level. Ponies must be measured to determine height before showing. Ponies will be measured during grading and exhibitor numbers will be marked PONY.
- 18. **Exhibitor Numbers:** Exhibitors will be assigned an exhibitor number. The exhibitor must wear this number throughout the entire week of the fair except for those horse shows that may issue their own special exhibitor numbers. The number must be displayed whenever the rider is astride the horse, horse in hand, lunging etc. Exhibitors are given their numbers at the completion of project grading.
- 19. Protective Headgear: Uniform Rules for 4-H Horse Shows (4-H Pub. #179, January 2021 edition) states "All youth age 19 and under, participating in any 4-H equestrian activity, are required to wear properly fitted protective headgear which meets or exceeds current ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards with the chin harness securely fastened at all times when riding or driving an equine. (page 6; General Rules#1) All junior fair exhibitors will abide by this helmet rule. It is the responsibility of the rider and the parent or guardian of the youth participant to make sure that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use and is properly fitted and in good condition. When buying protective headgear the buyer should look for ASTM and SEI designations, which indicate the headgear has met safety standards. Protective headgear is required whenever riding or driving an equine or when participating in Trail-in-Hand classes. NO EXHIBITOR WILL BE ALLOWED TO ENTER THE HORSE RING WITHOUT APPROVED **EQUINE PROTECTIVE HEADGEAR.** Improperly fitting helmets have been blamed for inflicting injury to a fallen rider. Exhibitors are strongly discouraged from swapping safety helmets. Parents choosing to lunge their child's horse/pony must wear safety headgear as well. Age Category and Novice riders participating in a Western Showmanship class may wear a Western Style hat. Walk/Trot riders participating in Western Showmanship are required to wear protective headgear.
- 20. **Bit Checks:** Random bit checks will be performed throughout the Fair by the judge during the fun shows, weekend shows and specialty shows.
- 21. **Show Ring Etiquette:** The judge will dismiss from the ring any entry the Judge feels is unruly or not in sufficient control for the safety of the handler or other exhibitors. Unsportsmanlike conduct toward judges, show management, or exhibitors, or physical abuse of the project horse will not be tolerated. The Junior Fair Horse Event Chair(s) and or Advisors will dismiss violators from the show.
- 22 **Mandatory Exhibitor's Meeting:** A meeting for all exhibitors and their parents or guardians will be held at 2:00 PM on Monday, July 15 in the Activities Tent. All exhibitors and their guardians must attend this important meeting.
- 22. Awards Ceremony:
  - a. Individual class awards are presented at the end of each class.
  - b. Versatility awards are presented at the conclusion of the Junior and Senior competitions.
  - c. State Fair Qualification Awards will be presented at the exhibitors meeting on Monday, July 15, to all 4-H Horse Projects graded at the fair who passed two or more events at a Performance Against Standard Qualifying Show (PAS).
- 23. **Stall decorations:** Clubs are encouraged to appropriately decorate horse stalls and barn areas to enhance the appearance of the barns. No decorations may be installed before **6:00 PM Saturday July 13**. Decorations may not be removed before **4:00 PM Sunday July 21**. Decorations must be safe and not limit barn or stall access in any manner.
- 24. **Overnight Camping:** Only exhibitors on Special Exhibit will be permitted to stay overnight and must stay in a permitted tent or camper in the Junior fair Campground and comply with all rules and regulations thereof. Per the *GENERAL JUNIOR FAIR EXHIBITORS' RULES AND GUIDELINES*, any Junior Fair exhibitor

- staying overnight on the fairgrounds must have a personal camping permit from the Senior Fair office and must have a responsible adult supervisor registered with the Senior Fair Office. This adult supervisor must be present at the campsite when the exhibitor spends the night.
- 25. **Horse Show Rules Committee:** The 2024 Junior Fair Horse Show Rules Committee is made up of the following: 4-H Horse Advisory Committee Officers, Junior Fair Horse Events Advisors and event Judge. In the event that an official protest is filed, Junior Fair Board Adult Advisor(s) and/or Senior Fair Board Representative(s) may be asked to serve to rule on actions taken by the Horse Show Rules Committee. Official protest must be filed in writing at the Senior Fair Office and must include a one hundred dollar (\$100) fee. The fee will be returned only if the protest is sustained by the Senior Fair Board.
- 26. **Trees**: The 4-H Horse Committee planted trees around the horse arena. Do not tie horses or ponies to the trees. Do not let horses/ponies eat the trees. Do not climb trees or allow children to climb trees. Do not break limbs or twigs off of trees or hang anything from them. Do not tear or cut into bark.
- 27. **Round Pens:** Round pens are for lunging of horses/ponies only (no riding anytime). First come first serve limited to 15 minutes per person. Supervision is required, helmets are required, and back numbers must be displayed. No riding in grassy areas outside of round pens. No use of round pens after lights out at midnight. Parents lunging horses must wear protective headgear.
- 28. **Permitted Riding Areas:** Exhibitors are permitted to ride their own project animal in the main area or the practice areas only. There is no other designated safe riding area on the fairgrounds. <u>Horses may be lunged</u> in the lunging pens only.
- 29. **Horse Permitted Areas:** Horses may be in the horse barn areas, the main and practice arenas, the lunging pens and wash racks. Horses are not permitted in the campgrounds, the mid-way, race barn areas or non-horse barns. Horses being moved between Barn 22 and the main arena must be in hand and not ridden. Horses are not permitted near the horse arena bleachers or West of the white fence or on the grassy hill behind barn 22.
- 31. Release Time for Horses: All Junior Fair project horse(s) on exhibit will be released at the end of the Golden Boot Awards on Sunday, July 21' or the time specified by Senior Fair, whichever is later. Horses are to stay until the end of the Golden Boot Awards. No trailers will be permitted on the grounds prior to the end of the Golden Boot Awards or the time specified by Senior Fair whichever is later. Trailers will be brought onto the grounds at the direction of Senior Fair board. Advisors are to be in the barns to ensure club members are following instructions. Following the end of the Golden Boot Awards, all advisors are needed to help gather all the equipment to be packed back into the announcer's stand. Exhibitors whose project horse(s) leave the grounds prior to this time without written authorization from the Junior Fair Board will not be allowed to exhibit at the Franklin County Fair the following year. Advisors are to be stationed in the barns to report any horses that leave before the release time. All stalls must be stripped and checked by club advisors by Monday at 9:00 PM.
- 32. **Release Time and procedures for Ohio State Junior Fair Horse Show:** Only State Fair qualified horses are permitted to leave during the Franklin County Fair. Exhibitors must provide a completed Franklin County State Fair Horse Show Release Form. The exhibitor must leave a clean stall with shavings while they are gone. A sign (provided by the 4-H Horse Advisory Committee) must be displayed on the horse stall indicating that the horse exhibit is representing Franklin County at the Ohio State Junior Fair Horse Show. If the exhibitor is not returning the horse to the fairgrounds, the exhibitor must return to strip the stall at the end of the fair. Absolutely no camper/trailer will be allowed to leave the campgrounds. **Release times and final release procedures will be posted at a later date.**

#### HORSE BARN SAFETY AND BARN KEEPING RULES

- 1. **Manure Handling:** All manure is to be placed in designated areas.
- 2. **Stall Use:** Nothing is to be attached to stalls in any barns. No nails, staples, wires, screws, etc. may be used. String or rope may be used to hang buckets and hay bags if it is tied around the main wooden structure. No paint may be used on any stalls including the portable stalls.
- 3. **Horse Care:** It is the responsibility of the exhibitors to properly care for their animals and use appropriate barn management practices. Stalls must be kept reasonably clean at all times. The barn stewards will periodically check stalls and if an exhibitor's stall is deemed unacceptable the exhibitor will be notified in writing. The exhibitor will be prohibited from showing his or her animal until the stall has been cleaned and approved by the barn stewards. Please report any problems to your advisor or one of the barn stewards.
- 4. **Barn Rules:** Each exhibitor shall be responsible for observing these rules.
  - A. NO SMOKING IN BARNS!
  - B. Extension cords and fans must be approved by the barn steward, be in good repair and UL rated for outdoor use with grounded, three-prong plugs. No heating appliances, cooking appliances, refrigerators or TV's may be used in the barns.
  - C. Electric clippers may be used. When using clippers, horses must be held by an attendant, not tied or left standing.
  - D. No tying or cross-tying animals in the barns, aisles or buildings outside the stalls. No tying of unattended horses in stalls or wash rack.
  - E. Horses must be attended to at all times except when closed in their stalls. Feed doors in Barn 22 must be closed at all times.
  - F. When using the wash rack, please CLEAN UP any mess made by the horse. PLEASE KEEP THE DRAIN CLEANED OUT. Limit wash rack time to 15 minutes. Remember excessive washing removes the natural oils and shine from a horse's coat. Wash racks will be closed during all grading events. Horses can be washed or rinsed off only in the wash rack. Do not use the water tap at end of barns to wash or rinse off horses.
  - G. NO PARKING IN THE BARN AREA. Unload and move cars, trucks, and trailers as quickly as possible. Keep the roads and area around the barns free from obstructions in case of fire or health emergencies. ALL trailers left on the fairgrounds must be parked in the designated parking area (south of Gate 6 and at least three(3) feet from the fence) as specified by the Senior Fair Board.
  - H. NO people door in any barn should be blocked or locked at any time the barn is being used. Do not store supplies/feed in the aisle ways leading to or from the people doors.
  - I. Please follow all SAFETY RULES. The following will be enforced:
    - a. No riding in campground or midway area or on the racetrack. Please dismount in horse area when it is congested.
    - b. No bare feet or sandals in horse area.
    - c. No double riding.
    - d. No riding in the barns.
    - e. No horseplay in the barns.
    - f. No riding of horses between Barn 22 and the riding arena.
    - g. An approved safety-riding helmet must be worn whenever you are working with the horse/pony.
    - h. Curfew for the horse area is midnight. There will be no overnight camping except for those properly registered with the Senior Fair Board in the camping area and under adult supervision.
    - Horses must have bridle or hackamore on when ridden. Riders must wear their number whenever riding, lunging, or handling the horse.
    - j. No leads across stall doors.
    - k. There will be barn stewards who have the authority to enforce rules and assign penalties in cooperation with the appropriate Junior and Senior Fair Board representatives.
    - 1. No drones permitted on the fairgrounds.
    - m. No selfie-sticks permitted on the fairgrounds.

Note 1 – Master Showmanship is open to 1st place winners of Classes 3, 4 and 5 and former Junior, Intermediate and Senior Showmanship winners of previous years. Exhibitors who won their showmanship division in 2023 must enter the next age division (i.e. Junior to Intermediate, Intermediate to Senior, Senior to Master). A Senior Showmanship winner may participate in the Senior Showmanship class after a one-year absence. (i.e. 2023 Senior Showmanship winner would be eligible for 2025 if he/she meets Junior Fair age requirements). The 2024 Senior Showmanship winner is the qualifying showman for the Showman of Showmen Contest to be held on Friday, July 19. See Showmanship and Showman of Showmen information in Livestock Special Events Section.

**Note 2** – For these classes only, Junior, Intermediate, Senior is defined as ages listed regardless of the riding level assignments. This is because the Senior Showmanship winner participates in the Showman of Showman Contest where all Senior Winners are 15-19 years of age or qualify via the rules that require last year's division winners to advance divisions.

- Note 3 Rider may only show in Western or Ranch classes, not both, per 4-H Pub. 179.
- Note 4 See General Horse Exhibitor Rule #17, Ponies Riders may not enter a similar class for horses.
- **Note 5** Easy-gaited horses may not enter Saddle Seat English Pleasure classes.
- **Note 6** Classes 36-39: If you are showing a pony, you may request the fences to be lowered without penalty, according to *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*.
- **Note 7** Classes 36-39: The 4-H member does NOT have to enter the same fence height for Equitation/Working Hunter classes.
- **Note 8** Classes 36 and 37 are shown by <u>skill level of the **rider**</u> according to *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*. You may only show in one of these two classes.
- **Note 9** Classes 38 and 39 are shown by <u>skill level of the **horse** or **pony**</u>. You may only show in one of these two classes.
- **Note 10** Exhibitors may only show in one reining class (class 44 or 45, not both). Pattern A is recommended for beginning reiners, pattern C is recommended for reiners and advanced riders.
- **Note 11** Exhibitors may participate in only one Trail or Trail-In-Hand class. All participants must wear protective headgear in the Trail-in-Hand class regardless of riding level.
- Note 12 Classes 68-77: Exhibitors may show in all English (tack and attire) or all Western (tack and attire).
- **Note 13** Western tack is required per *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*. Classes 78-89 are for "age category" riders only. Walk-Trot and Novice riders may not enter these classes.

1. **Horses On Special Exhibit Only:** Only Junior Fair Exhibitors having a horse, pony or mini on special exhibit may enter the Junior Fair Horse Fun Shows.

- 2. **Definition of Pony and Small Equine:** A pony is taller than 38" and under 58". A mini is 38" and under from the last hairs of the mane. If showing in pony or mini class, the pony or mini may not be entered in any horse class of your age group or riding level.
- 3. Combining Classes: Classes may be combined or split if deemed necessary by the Show Committee.
- 4. **General Horse Rules:** Carefully read all General Horse Exhibitor Rules in this book.
- 5. **Show Attire: Evening** fun show participants must wear **formal show attire** per *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*. Morning fun show class participants must wear boots, long pants, T-shirt (no sleeveless and no bare midriffs). Attire for morning fun shows should be conservative and appropriate for public viewing. Display of excess skin may result in the exhibitor being asked to change clothes or denied right to participate.
- 6. Show Attire for Contest Classes held during the weekday:
  - Carrot Temptation, Catalog Race, Flags, Potato in the Bucket, Egg & Spoon and Ride-A-Buck, may be shown in English or Western Tack and Attire or mixed.
  - Barrels, Pole Bending, Speed and Control, Barrels and Cones, Stakes Race and Key Hole must be run using Western Tack, but rider may have on English Attire.
  - Ride-A-Buck is the only class ridden bareback.

#### 7. Show Attire for Contest Classes held during the evening:

- For evening shows *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)* applies and attire and tack must be WESTERN.
- Ride-A-Buck is the only class ridden bareback.

- 1. **Eligibility:** Any Jr. Fair participant age 5 and in Kindergarten and older enrolled in 4-H, Boy Scouts and Girl Scouts. Members are defined as 4-H members who completed projects and grading.
- 2. **Type of Model Horse Required:** Model horses may be Breyer or any model horse between 6 to 11 inches tall (highest point to ground).
- 3. Show Attire: Show attire is preferred. Club shirts and long pants acceptable. NO Shorts or Sandals.

- 5. **4-H Project Member Classes Only:** Classes 2, 5, and 10 are open to Franklin County 4-H Youth ages 8 and in the 3rd grade or age 9 any grade as of January 1st or the current year through age 18 as of the current year enrolled in any 4-H project without a horse on Special Exhibit.
- 6. Classes 7 and 11 are open to ALL 4-H members, Boy Scouts and Girl Scouts.
- 7. Classes, 3, 6, 8, and 12 are open to Franklin County Cloverbud Youth (5 years of age and in Kindergarten through second grade and enrolled in 4-H).

### **Class Descriptions:**

- A. **Showmanship** Exhibitors will work with a model horse. They will need to follow a pattern using correct gaits and be on the correct side of the horse at all times. They will be asked to name parts of the horse. They will be judged on appearance, cleanliness and condition of model horse.
- B. **Trail Class** A course diagram will be posted prior to the show time. The exhibitor will take their model horse through the course as the diagram instructs using correct gaits (walk, trot, lope) between each obstacle.
- C. **Costume Class** Be creative. Both horse and exhibitor may be dressed up or just the horse. Class will be judged on creativity and originality.
- D. **Homemade Saddle Class** Make saddle prior to show. Saddle to be homemade not store bought. Any materials may be used. Class judged on creativity and originality. Saddle should fit model.
- E. **Hunter Over Fences** Exhibitor will take model horse and work through a jump course following the correct course that will be posted before the show.

1. **Eligibility:** This competition is designed for advanced riders on special exhibit and is open to all types of horses (english, western, gaited). A member must be in at least the 3<sup>rd</sup> year of a 4-H Horse Project (excludes Horseless Horse and/or Horse Relationship projects). Youth showing in walk-trot or novice classes throughout the fair are ineligible for versatility.

#### 2. Age Divisions for Versatility:

**Junior** Versatility participants must be 10 to 14 years of age as of January 1, 2024.

Senior Versatility participants must be 15 to 18 years of age as of January 1, 2024.

- 3. **Guiding Rules:** The class is shown in accordance with applicable current *Uniform Rules for 4-H Horse Shows* (4-H Pub. #179) and General Horse Exhibitors Rules listed in the front of this book. Classes will be posted at the announcers stand.
- 4. **Bit Checks:** The judge will perform bit checks before each class. Illegal bits are disqualifying. Entry using an illegal bit will be permitted to participate in the class, however, they will receive a score of zero for the class(es) that the illegal bit was used.
- 5. **Rider Assistants:** Each rider may have a maximum of two assistants. Only one assistant may be helping in the ring at a given time, giving assistance to the rider. Violators will be disqualified for the class following the tack change. Arena assistant must wait until announcer says go before entering the arena. Violators will be permitted to participate in the class following the tack change, however, they will receive a score of zero. Rider assistants should refrain from leaving or going back to the stall once the show has started. Rider assistants may not throw equipment into the ring once the show has started. Rider assistants cannot talk to exhibitors when in line-up, ready to show. Rider assistants must be identified on the entry form. Only the two rider assistants may be within five feet of the horse and rider at the rail during the show and are the only ones permitted to communicate with the rider. There will be a mandatory meeting for exhibitors and their assistants prior to the competition.
- 6. Tack Changes: All tack changes must be made in the ring. Riders must remain on the horse until announcer says go. The rider may not leave the ring. All changes of tack and appointments must be made within the five-minute interval between events or the entry will be disqualified. (Entry will be permitted to participate in the class following the tack change, however, a score of zero will be given). The rider must be mounted on the horse and ready to ride at the end of the five-minute tack change. "Ready to ride" means horse and rider are in the center of the arena, standing still and facing the announcer stand. Arena assistant must be out of the arena by the end of the five-minute time. Show Steward and the Judge will be in the arena during the tack changes to monitor riders and rider assistants. At the end of the five-minute tack change, when all horses are in the designated area of the arena, the announcer will ask all riders to check their girths. Any rider needing their girth tightened will be allowed to have their ring assistant come into the arena and assist with tightening of the girth. Only the rider's ring assistant will be permitted to help tighten the girth. NO OTHER ADJUSTMENTS may be made to tack, clothing, etc. Judge may check the entries for proper tack and equipment.
- 7. **Warm Up:** There will be a two-minute warm-up period allowed for horses prior to the Versatility gymkhana class.
- 8. **Horse and Rider:** Each rider must show in all events and must use his or her own horse in each event. The horse used must be the same horse for all events. Judges will place each class one through ten. First Place will receive 10 points, second nine and so on through tenth place will receive 1 Point. If there are more than 10 participating in the class, those not placing in the top ten will receive 0 points for the class. Points are totaled for all four classes to determine the overall placing.
- 9. **Tiebreakers:** The winner of the Versatility Class will be the horse and rider accumulating the most points in the four events combined, and lower placings will be similarly determined. In the event of a tie in the number of

- points, the exhibitor with the highest combined horsemanship and equitation scores will determine the placing. If a tie still exists showmanship will serve as the second tiebreaker.
- 10. Showing in fewer than four events: To win the Versatility Contest the horse and rider combination must complete all four classes. Once a horse and rider combination does not show in a class or leaves the ring and drops out of a class the contestant may not enter any subsequent class. The horse and rider combination placing in any classes completed will stand for the classes that were completed and will be eligible for the class rosette ribbons. Any accumulated score will not be considered for the overall versatility award. Contestants placing lower in a class than a contestant that drops out will not be awarded a greater number of points because the contestant has dropped out of the contest.
- 11. **Disqualification in Gymkhana event:** Contestants who perform in the required gymkhana event but disqualify for any reason receive zero points for that event. These contestants are still eligible for the overall Versatility Award. Riders must remain on their horse and in the designated area during the entire gymkhana class.
- 12. Entries: Parent/legal guardian and 4-H advisor must sign the entry giving consent for the youth to participate. Completed entries must be submitted by Tuesday, July 16, 3:00 PM to the announcer's stand at the Nationwide Children's Hospital Horse Arena. Please see Becky Applegett.
- 13. Ring Etiquette: Horses must be under control by exhibitors at all times. Ring manners and etiquette must be known and followed.
- 14. Show Order and Classes: Senior Versatility will follow Junior Versatility.

**Enforcement of Rules:** All General Horse Exhibitor Rules will apply for this show. Any rule broken will disqualify the exhibitor from this show. No exceptions!

Number of Entries: One entry per exhibitor. One rider and one horse per division, unless riding Teams.

Class Selection: Exhibitors must ride in the class that matches their riding level.

**Required Entry:** Each exhibitor must fill out an entry form online. **The completed entry form with electronic song (.mp3, .mp4 or .mov) and a copy of the lyrics** must be submitted online, which will then be sent to the Musical Freestyle Committee and will also send you a confirmation back to the email you provided on the form. This must be done by **July 3.** The Musical Freestyle form may be changed as many times as needed, up to the deadline, if you use the confirmation email that will be sent back to you once submitted.

**Guiding Rules:** Refer to General Horse Exhibitors Rules in this book. Please read all rules carefully and comply with rules at all times.

Music Selection: Selected music must be turned in with the entry form. Written lyrics of musical selection must be submitted with entry. Song length: minimum – 2 minutes; maximum – 4 minutes. No exceptions!

**Screening of Music:** The Musical Freestyle Show Committee will listen to the music and review the lyrics prior to the fair. If the music is found to be inappropriate, the exhibitor will be asked to select a different song. Absolutely no reference to alcohol, drugs, sexual implications, sexual preference or violence will be accepted. Exhibitors will have up to **3 days** after notification to edit their entry form to change the music and lyrics. If there is any question that the music may be inappropriate, pick another piece of music. The decision of the Committee is final and cannot be contested.

**Practice:** Practice will be held on **Thursday**, **July 18** approximately 30 minutes following the morning fun show. Schedule for practice will be available in the announcers stand, by Tuesday, July 16.

**Show Order and Posting:** Order of go is randomly picked; if you need to be spaced apart from someone, please notify the advisor for the Musical Freestyle Show at time of entry. Attempts will be made to honor the request, but not guaranteed. An order to go list will be posted prior to the show. It is the exhibitor's responsibility to be waiting at the gate to enter the class. Please help the show run as smoothly as possible.

### **General Rules – Musical Freestyle:**

- 1. Exhibitors will only be judged astride their horses, except for Ground Tie and/or Small Equine.
- 2. Exhibitors are allowed to use two (2) hands (as well as one hand or no hands). Bridles must be worn, but not necessarily used, at all times.
- 3. All costumes and props are subject to committee approval. No sharp items will be allowed. No smoke bombs or loud effects are to be used. If props are used, you will have a total of five minutes for set up and five minutes for removal of props. A **five-point penalty** will be given if time is exceeded. Horse and rider may not enter the arena until all props have been set up. Anyone sitting on the fence or entering the arena with the rider is considered a prop and must be listed on entry. All riders as well as anyone in the arena or sitting on the fence must wear appropriate clothing. The rider and anyone entering the arena with the horse and rider must wear closed toed shoes. The Musical Freestyle Advisor reserves the right to rule on costumes, props or attire that may be inappropriate, offensive, or unsafe. When costumes or props are deemed unsafe, offensive or inappropriate the exhibitor may be disqualified. Any changes or additions to props, special request or dedications must be submitted by **July 3** using the **confirmation email sent after submitting the first form.**
- 4. Saddle and bridle must be from the same seat; i.e., Western bridle with a Western saddle and an English bridle with an English or Saddle Seat saddle. If riding bareback, either English or Western bridles may be used. Bits must be as approved in *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)* for that style of tack (bosals or snaffle bits acceptable on Western horses 5 years and younger).

- 5. Riders will be allowed to mount and or dismount their horses in the show ring.
- 6. Any rider who falls from the horse or is expelled by the horse will be disqualified.
- 7. Any horse that is not being controlled by the rider, at the judge's discretion may be stopped, excused from the class and disqualified.
- 8. Use of illegal equipment, riding without a bridle on horse, or any act of abuse to the horse will result in contestant being disqualified.
- 9. The decision of the judges will be final and cannot be contested or disputed.
- 10. No more than one horse in the show ring during a performance, except for the Team Class. No other animals allowed in the ring with the horse.
- 11. The judge may perform a bit check at the end of each member's performance if there is a reason to doubt the bit is legal.

**Judging:** Two judges will officiate the show. Each judge will independently score each contestant. The points awarded by the two judges will be summed and the exhibitor receiving the highest total number of points will be placed first. Second highest score is second place and so on down the placings.

**No Ties:** No ties will be awarded. If there is a tie when the two judge's scores are summed the higher placing will go to the contestant who has the highest combined sum for Technical Difficulty (Judge A + Judge B). If there still is a tie the likewise sum for declared skills will determine. If these scores are the same too then Choreography / Creativity will determine. If there still is a tie then Costume and finally Crowd Appeal will be used to determine the placings. In the unlikely event that both contestants have identical combined scores in all categories then the tiebreaker will be selected via a coin toss.

**Team Class:** A team is limited to two riders. Two horses must be used. One rider per horse and it must be the rider's own horse. Two riders are not allowed to use one horse. Exhibitors may be of any age category riding level in order to compete in this class (**Walk/Trot and Novice may not participate**). Both riders must perform the three declared skills, **these are the same three skills for both riders**. Each rider is scored individually on technical difficulty and three declared skills. The scores will then be averaged and one final score for each of the riders as well as the team score for choreography/creativity, costume and crowd appeal will be given per team. Team Class Riders may not participate in any other Musical Freestyle classes.

#### Performance Score based on:

**Technical Difficulty (20 points)** – Exhibitor will be judged on overall degree of difficulty in performance. Moves made in addition to the three declared skills will be considered in the score.

Three Declared Skills (25 points) – Exhibitor must select three skills from choices listed on the musical freestyle entry form. Judges will score these maneuvers based on exhibitor's riding ability and the horse's ability to perform. Multiple repetitions of the declared skills will be averaged (ie. once excellent and once poor would equal average).

**Choreography/Creativity** (25 points) – Exhibitor will be judged on how well the arrangement of moves are planned or put to music. Overall imagination will be considered.

**Costume (20 points)** – Score will include how creative and how well the costume and/or any props coordinates with the theme of the music.

**Crowd Appeal (10 points)** – Judges will determine how well exhibitor entertains the audience.

#### **Disqualifications:**

- If costumes or props are deemed unsafe, offensive or inappropriate.
- Any rider that falls from their horse or is expelled by the horse.
- Any horse that is not being controlled by the rider.
- Breaking a rule in the General Horse Exhibitor Rules or *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*
- Use of illegal equipment, riding without a bridle on horse, or any act of abuse to the horse

**Penalties:** (5 points each) – For exceeding prop set-up time or tear-down time of 5 minutes maximum

(1-5 points) – For undeclared props

- **Note 3** Classes 1-2 are shown by <u>skill level of the **rider**</u> according to *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*. You may only show in one of these two classes.
- Note 4 Classes 3-4 are shown by skill level of the horse or pony. You may show in only one of these two classes.
- Note 5 See General Horse Exhibitor Rule #17, Ponies Riders may not enter a similar class for horses.
- Note 6 Rider may only show in Western or Ranch classes, not both, per 4-H Pub. 179.
- **Note 7** Exhibitors may only show in one reining class (43 or 44, not both). Pattern A is recommended for beginning reiners and Pattern C is recommended for reiners and advanced riders.
- **Note 8** Western tack is required per *Uniform Rules for 4-H Horse Shows (4-H Pub. #179)*. Classes 59-70 are for "age category" riders only. Walk-Trot and novice riders may not enter these classes.
