**Who Must Attend:** A Parent or Guardian is required to participate with youth offenders for the entire program, regardless of their age.

Parents/Guardians of non-court referred youth are not required to attend unless proof of attendance is needed by the court/legal system.

# WHAT IS 4-H CARTEENS

4-H CARTEENS is a program designed and operated by collaborative partners and youth volunteers from Franklin County. The goal of 4-H CARTEENS is to reduce the number of second time traffic offenders in Ohio by having driver safety information taught to teens by teens. Professionals in the field also share information.

For those referred for traffic violations as a court order, failure to successfully complete the program will result in a license being automatically suspended by the court. A citation may also be issued requiring a return to court.

## NON-COURT REFERRED PARTICIPANTS WELCOME!

The 4-H CARTEENS program is a proven preventative educational tool for any teen that gets behind the wheel. We encourage siblings to attend with court referred youth free of charge on the same evening.

All other youth who have not been court/diversion program referred to the program and/or have not been issued a traffic citation are welcome at a reduced rate of \$25.00. IN THIS CASE, NO ATTENDANCE DOCUMENTATION WILL BE SUPPLIED, so if you need proof of attendance, you will not want to select this option.

## Program Guidelines (Please read all of this information carefully)

- The 4-H CARTEENS program will be held on the date assigned. Check-in runs **from 6:00 – 6:30 p.m.** The session begins promptly at 6:30 p.m. and those arriving late will be considered absent and will not receive any court attendance credit.
- A non-refundable fee of **\$50** will be collected. Parents/Guardians will not be charged for attendance.
- **All participants must attend with a parent/guardian regardless of their age**, and participants will not be permitted to leave before the session is completed. Those leaving will not receive court attendance credit and will be required to appear for a further court hearing.
- **All cell phones and other devices must be turned off** during the program by all participants including parents/guardians. Reading books, etc. is also not permitted. Please contact your court/diversion personnel if you are unable to adhere to this policy.
- The program location is a smoke-free building. **Smoking is not permitted.**
- **Respectable behavior is required** at all times during the session. Any youth and their parents/guardians exhibiting unruly, disrespectful or uncooperative behavior shall be removed from the session. Court referred offenders will be reported to Juvenile Court personnel and the court will provide instructions regarding a further court hearing.
- **Vending machines are NOT available** on site. You may bring a bottled or canned non-alcoholic beverage, or a beverage in a cup.
