If your credit score is **640** or greater and one of the following apply to you, we recommend registering for the FREE Home Buyer Education Workshop:

- Ready to learn the entire home buying process
- Interested in down payment/closing cost assistance programs
- · Steady income for the last two years
- Pre-approved by a lender
- · In-contract on a home

You will learn:

- The steps in the home buying process
- How to apply for a mortgage loan
- · How to understand your credit
- How to select a lender, realtor, home inspector, and insurance agent
- How to budget to buy a home
- · What happens at closing
- About down payment and closing cost assistance programs

To receive a HUD-certified Certificate of Completion, participants must:

- Complete both workshops and intake form
- Complete one-on-one Budget and Credit counseling

Super Savers Club (SSC)

OSU Extension can help you establish an *Emergency Savings Fund.*

Only income eligible participants who successfully complete the OSU Extension's **MM** *or* **HBE** will receive an *invitation* to join the SSC.

SSC members who save *up to* \$600 in a *SAVING ACCOUNT* are eligible to receive a match of up to \$600 *only after 90 days of saving and completing <u>additional</u> online Financial Literacy/Education modules.*

<u>Money Management</u> <u>(MM)</u>

MM Participants will learn how to set SMART financial goals, create a budget, improve credit and reduce debt. They will also learn about savings and borrowing options!

Is your credit score below 640? Do you want to prepare your teenagers and family for financial literacy and build generational wealth? Attend this FREE Money Management Workshop.

Upon completion of the full 8-hour course, you will receive a Certificate of Completion a free one-on-one Budget/Credit Counseling session.

FYI: Medical Debt Changes on all 3 Credit Reports

- Paid medical collection debt will no longer be included on consumer credit reports, as of July 1, 2022.
- The time period before unpaid medical collection debt will appear on a consumer's report will be increased from six months to one year, also effective July 1, 2022. This change gives consumers more time to work with insurance and/or healthcare providers to address medical collection debt before it appears on credit reports.
- Medical debt collection accounts under at least \$500 will no longer be included on consumer credit reports. This goes into effect the first half of 2023.

Student Loan Debt Taking Control of Student Loan Debt

Did you know that \$0 Deferment or Forbearance can *negatively* impact your Debt-to-Income ratio for a mortgage loan? Learn what payment options will help fulfill your dream of homeownership. You will also learn about who qualifies and the required procedures to earn Public Service Loan Forgiveness (PSLF). "It's not what you do, it's where you work." Learn about new updates and additions to several Student Loan Forgiveness programs.

Prepare for repayments starting September 1, 2022, after the \$0, 0% COVID Forbearance period ends. All old payment plans will need to be renewed with your loan servicer.

Navient, FedLoan Servicing, and Granite State will **no longer** be servicing Student Loans. Learn how to contact your new loan servicers.
