Home Buyer Education (HBE)

HBE participants will learn how to obtain, maintain and retain a home of their own!

To receive a HUD-certified Certificate of Completion, participants must:

- Have a minimum FICO Credit Score of 640 or above to enroll
- · Complete Workshop One
- Complete Budget and Credit Counseling
- Complete Workshop Two (Scheduled by Housing Counselor)

Home Buyer Education is a total of eight hours instruction (two four-hour sessions) and budget/credit counseling. Those who complete eight hours of instruction and participate in a one-on-one budget/credit counseling session will receive a HUD-certified Certificate of Completion, which often is required to apply for many down payment/closing cost assistance programs and/or grants. It's Income Tax Time!

Below is a list of items and information you should gather prior to filing your tax return.

- Social Security numbers for you, your spouse and dependents
- Birth dates for you, your spouse and dependents on the tax return
- Wage and earning statements (Form W-2, W-2G, 1099-R,1099-Misc)
- Dividend statements from banks (Forms 1099)
- 1098-E (Student Loan Interest) 1098-T (Student Tuition)
- Bank account routing and account numbers for direct deposit
- Total paid for daycare expenses and the daycare provider's tax number
- Form 1095-A, B or C, Health Insurance Marketplace Statement

Without an Emergency Savings Fund, you will run the risk of an eviction, foreclosure, utility shutoff, loss of transportation and much more. If you lose your job, become sick and unable to work, you still must pay rent, utilities, groceries, insurance, car payment, medical bills or other living expenses.

Let OSU Extension, in partnership with the University District Organization, help you establish an emergency savings fund through the OSU Extension Super Savers Club (SSC)!

It is important to put 3–6-months worth of living expenses into a dedicated Savings Account in preparation for the unexpected. Only income eligible participants, who successfully complete the OSU Extension **Money Management** workshops will receive an invitation to join the SSC.

SSC members who save up to \$600 are eligible to receive a maximum of \$600 after 90 days of saving and attending additional online Money Management classes.

Members of the Super Savers Club will also receive information about other opportunities, programs and services. Don't delay and register for our Money Management classes today!
